2020 YOUNTVILLE GENERAL ELECTIONS

Do you want to serve your Community? Consider becoming a Town Council Member! The Town of Yountville is preparing for the Consolidated Statewide General Municipal Election coming up Tuesday, November 3, 2020. The Town will be seeking Nomination Papers for two (2) Council Member positions, starting July 13, 2020.

The ballot also include Measure T for Yountville voters to decide if they want to allow a Cannabis business in Town. The language in the ballot will read as follows:

"Shall the measure authorizing the Town Council to approve one cannabis retail business allowing retail sale, delivery, and/or on-site consumption of adult-use cannabis in the Town of Yountville excluding residential zones, allowing the Town to establish regulations and fees, requiring a use permit and conditions to operate, and permitting the Town Council to establish an ongoing general tax up to 3% on the business' gross receipts to raise an estimated \$30,000 to \$100,000 annually, be adopted?"

Those interested in running for office must be 18 years of age and a resident and registered voter in the Town of Yountville. To learn more visit www.townofyountville.com/elections.

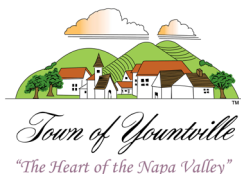
