NOTICE OF VACANCIES FOR TOWN BOARDS AND COMMISSIONS

Have you ever had a desire to make an impact in Yountville? Are you passionate about the arts? Do you want to help improve traffic congestion in the County? Do you want to help promote local food production and consumption? If you answer yes to any of the questions above, then joining one of our Yountville Boards and Commissions might be the right fit for you!

The Town currently has multiple openings on different boards and commissions. The openings are as follows:

- Yountville Arts Commission is seeking (4) individuals with terms of office starting on July 22, 2020 and expiring on July 21, 2022. As a member of this Commission, the selected individuals shall provide vision, leadership, inspiration, and support to artist and their art in Yountville. You will also sever in an advisory capacity to the Town Council and staff in matters pertaining to the cultural arts.
- Parks and Recreation Advisory Commission seeks one (1) High School representative with the term of office to commence immediately and expire in January 2021. This Commission advises the Council and staff on matters that pertain to facilities, parks, public recreation, and an array of activities for all ages. This Committee provides advice and helps develop plans and programs to address traffic congestion.
- NVTAC Citizen Advisory Committee (CAC) has an opening for one (1) individual to serve as the Yountville Representative with the term of office to commence immediately and expire approximately February 1, 2022.
- Napa County Local Food Advisory Council is recruiting for one(1) individual to serve as the Yountville Representative with the term of office to commence immediately and expire February 17, 2021. This Council focuses on the development and facilitation of a sustainable local food system and provides a forum for public input regarding related issues.
