Drought & Water Conservation Update

At the April 5 Town Council Meeting, Director of Public Works John Ferons presented a staff report on the Town of Yountville's water conservation status and there were two big announcements made. The first being Governor Newsom signed an executive order that continues to put the majority of responsibility at the local level and encourages water suppliers to maintain a Phase 2 Water Shortage Emergency regulations. The second announcement came from CalVet informing the Town that the next year's water allocation will continue to be the same level, 400 acre per feet. Which is a 20% reduction.

The Town of Yountville continues to be in severe drought conditions. Director Ferons expects Napa County to move into the extreme drought classification very soon. He also noted that the Town has failed to meet the 20% of water reduction in both the month of February at 15% and 17% reduction in March, respectfully.

Residents are urged to increase conservation efforts by downloading Eye On Water and register at www.eyeonwater.com/signup where water usage can be monitored on a hourly and daily basis from anywhere.

What happens if I use too much water?

If more than the allocated amount of water is used, the Town will take several steps to help educate residents with how to comply with state-mandated water restrictions.

- Courtesy Door Hanger Notice Informational Door Hanger letting someone know they are currently not compliant, **not an official violation**.
- Courtesy Notice of Violation Informational Letter with request of confirmation, **not an official violation**.
- Notice of Violation - **Official violation**, issued with a 15-Day Timeline to respond, fines may apply beginning at \$100.
- Additional notices - If the first violation is ignored, then fines may be attached to the account. The Town does not want to impose fines but needs your help in this regard.


