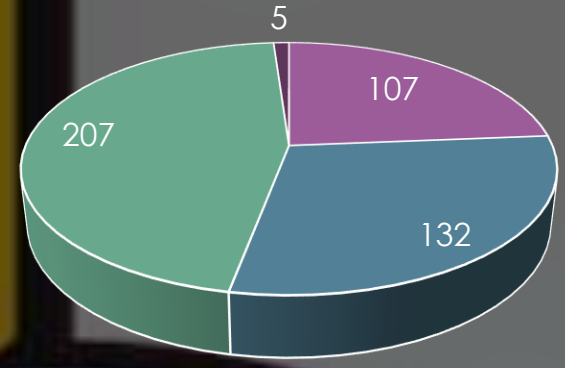

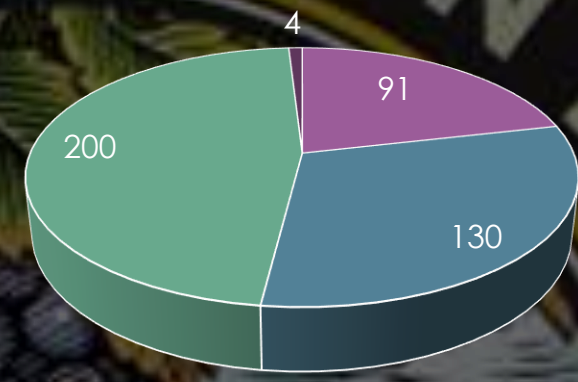

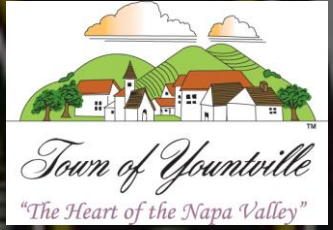

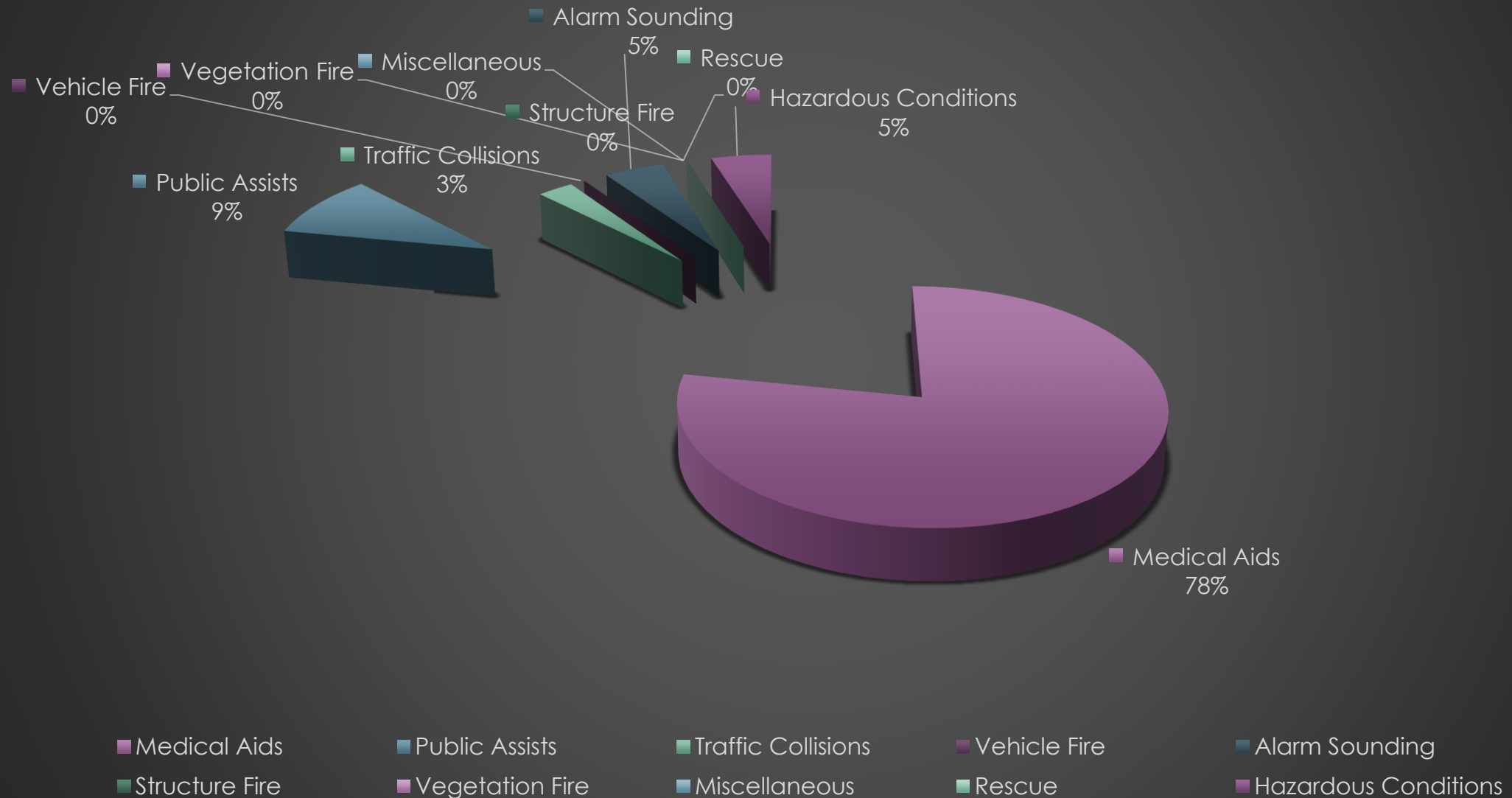
Requests For Service 5 Year Average

### Statistical Analysis

The attached spreadsheet shows a total of 486 calls for the three-month period. This includes the total number of calls responded to by Yountville Station personnel. The breakdowns of emergency calls in the town of Yountville are as follows:

Medical Aids:	82
Public Assists:	10
Traffic Collisions:	3
Vehicle Fires:	0
Alarm Soundings:	6
Structure Fires:	0
Vegetation Fires:	0
Miscellaneous Fires:	0
Rescues:	0
Hazardous Conditions:	4
Tree/Power Lines Down:	0

Of the total 486 calls, the breakdown according to response area is as follows:

Town of Yountville:	105 Calls
Veterans Home:	248 Calls
County Areas:	127 Calls
Napa City:	6 Calls

These averages are mostly consistent with history and call analysis. As is typical with virtually all Fire Departments today, our largest call volume continues to be medical emergencies.



## **Major Events**

### **Structure Fires:**

During the past three months Station 12 units responded to numerous structure fires throughout the county. Due to the quick response and good work from the crews, all the fires have been held to minor damage.

### **Vehicle Accidents:**

Engine 12 and Truck 12 continue to respond to an unfortunate amount of traffic collisions resulting in injuries and fatalities, this past quarter has been no exception. We would like to remind everyone to obey the speed limits, never drink and drive and to pull over when tired.

### **CPR:**

Station 12 is always busy with responding to medical aid emergencies and this quarter was no exception. The highly-trained staff at Station 12 administered CPR numerous times over the last three months both in town, at the Veterans Home, and in the nearby county areas. Our specialized equipment continues to help us provide the highest quality of BLS care to our patients.

### **Special Events:**

Station 12 personnel continue to remain committed to making Yountville a special place to live work and visit. Over the last three months Station 12 staff have helped with several special events. Station personnel helped with various community events, sometimes behind the scenes.

Station 12 personnel participated in a career day at the station for local high school students. They were able to tell the students about their life experiences, education and what brought them to be a firefighter with Cal Fire.

Engineer Derek Boynton accepted a permanent position in Cal Fire's San Mateo Santa Cruz Unit in August. It was hard to see him leave and we wish him the best. We received a new team member Engineer Kyle Black. Kyle lives in Paradise with his wife and they are expecting their first child later this year.

### **Training:**

We are privileged to be stationed near the Napa County Training Grounds and always stay busy with training. Not only do we try to train daily on various topics with our crew at Station 12, we also have our monthly drills with the surrounding stations. We are tasked with a specific topic for each month and train with multiple other engine crews. This quarter's training included; our annual fire ground skills testing, supply lines, hydraulics and pumping operations, and confined space. The Napa County Technical

Rescue Team monthly drills consisted of high angle rescue operations, rescue command, and exterior building shoring. The Rescue Team along with Rescue and Truck 12 participated in Urban Shield training exercise where they worked with regional cooperators preparing and honing skills in case of disaster. Station 12 Personnel working with the Napa County Hazardous Materials Response Team also participated in the Continuing Challenge in Sacramento, a training symposium.

We like to be involved within the community not only with special events but spreading knowledge and teaching fire prevention. This quarter we participated in multiple walk throughs with local businesses, wineries, and homes. A walk through of a building allows us to get to know the contents, fire prevention systems, and layouts of the structure.

### **Safety Message**

As we transition to fall and winter it is imperative that we remain vigilant and do not become complacent with the very real threat of wildland fire. It is also a good time to prepare you, CAL FIRE would like to remind homeowners of defensible space. We encourage removing dead dry vegetation within 100 feet of your home.
