- Violations are considered a public nuisance and subject to enforcement in accordance with this SOP and SHMC Section 1.12 et. seq.
- For violations due to barriers outside an individual or businesses control (extenuating circumstances) and when a substantial effort is made towards compliance: Individuals and businesses can be placed on a Corrective Action Plan.
- If an individual or business does not meet Notice of Violation (NOV) or Corrective Action Plan (CAP) deadlines, the Town has another opportunity to exercise enforcement discretion by determining when to commence an action to impose administrative civil penalties in accordance with this SOP and SHMC Section 1.12.250.
- When the Town commences an action to impose administrative civil penalties, it shall serve an accusation and hold a hearing—if requested by the respondent
- All Violations will be reported to CalRecycle and Upper Valley Disposal.
