



## **Peddlers and Solicitors Permit Application**

Chapter 5.20 of Title 5 of the Yountville Municipal Code establishes the Town's policies regarding Peddler and Solicitor activities. A "peddler" is defined as a person selling and making immediate delivery or offering for sale and immediate delivery of any goods, wares, merchandise or thing in possession of the seller at a public place within this Town or by going uninvited to the residence or place of business of any person. A "solicitor" is defined as a person selling or taking orders or offering to sell or take orders for goods, wares, merchandise or things for future delivery or for services to be performed, at a public place within the Town or by going uninvited to the residence or place of business of any person. Only peddlers and solicitors with a valid Peddlers & Solicitors Permit issued by the Town may peddle or solicit in the Town's public right-of-way. Permits are valid for a period of one year from the date of issuance.
